Dear _____ Family:

On December 1, 2011, the Army will implement the School Year (SY) 2011-12 Army Child & Youth Fee Policy as required by the SY11-12 Department of Defense (DoD) Child Care Fee Policy. The Army Fee Policy covers all Child Development, School Age, and Sports programs. There are several changes that will affect the fees you are currently paying.


By law, child care fees are based on total Family income (TFI) not rank or civilian grade. Every TFI category has a corresponding fee for each individual CYS Services program. The fees for Fort Belvoir are enclosed.

The biggest change to this year's fees allows Child Development Center and/or School Age Care Families to select a 2- or 4-week Leave/Vacation Fee Plan (which reserves their child's space) for each Child enrolled in the Regularly Scheduled Child Care Programs. Selection will occur during the Family's initial or re-registration for the upcoming 12 months. Families who choose the 4-week *Leave/Vacation Fee Plan* will pay a higher monthly fee than Families who choose the 2-week plan since their fees are annualized to include Leave/Vacation. Once a *Leave/Vacation Fee Plan* is selected, it remains in effect for their entire registration year (12 months).

When CYSS fees present a financial hardship, there is a process for Commanders or their designees to adjust individual Family fees on a case-by-case basis for documented financial hardships. Please inform the CYS Services Coordinator if you are experiencing any special circumstances which may need to be addressed.
